Gary Thibault to Retire From SCWCC Executive Director Post

Gary R. Thibault, Executive Director of the South Carolina Workers' Compensation Commission (SCWCC), announced his retirement from an extensive career in public service. His departure will take place in March 1, 2009. Mr. Thibault will continue to work with the agency in a consulting capacity assisting with the transition and with medical issues.

"The Commission is thankful for the leadership he provided and for the many accomplishments the Commission saw during his tenure," says Andrea Roche, Chairman. "His experience and expertise are well regarded in the workers' compensation community, both statewide and nationally. His reputation for impartial, objective analysis was matched by his understanding of the issues."



Mr. Thibault joined the agency in 1988 as director of the Commission's Department of Insurance & Medical Services prior to being named Executive Director in June 2005. Among his accomplishments while at the Commission are the development of medical fee schedules that promoted access to quality care at a reasonable cost, implementation of a new hospital inpatient and outpatient payment system that saved South Carolina insurance carriers and employers significant amounts annually, improving the timeliness of hearing cases and appeals and the oversight of a new, multimillion dollar computer system.

"Thousands of South Carolina's injured workers and employers have seen claims successfully administered each year due in large part to Gary's leadership and vision," says Rusty Goudelock, SCWCEA President. "He has implemented many effective changes during his tenure that will continue long after his departure."

2008 Annual Educational Conference a Success

If you missed the 2008 SCWCEA Educational Conference, you missed a good one. Held at the Hilton Head Marriott Resort and Spa, the thirty second annual Educational Conference was a great opportunity to learn more about the workers' compensation system, meet the commissioners, see friends, colleagues, clients, vendors, earning continuing education credits and have a good time throughout it all.

The program kicked off with the opening reception on Sunday evening, featuring the *Kids' Chance Silent Auction*. This is one of their bigger fundraisers of the year—raising over \$18,000 while attendees had time to meet colleagues and get to know others new to the organization.

The program began on Monday with the presentation of the colors by the U.S. Marine Corps color guard unit from Parris Island. The first event was *Meet Your S. C. Workers' Compensation Commissioners* with Commission Chairman Andrea Roche, and Commissioners Derrick Williams, Susan Barden, Avery Wilkerson, and Scott Beck. This was followed by the inspiring presentation of Dan Miears and his *Journey Back to Life After a Catastrophic Injury* to remind everyone about the focus of the whole workers' compensation system.

You Be the Judge delivered information in a new interactive format. Each participant had a wireless instant response handset and found out how their knowledge compared to all other participants and the presenters, with the compiled results displayed on the screens at the head of the hall during the session. Kenneth Richstad, Clerk of the Court of Appeals discussed the appeal of compensation claims to the Court of Appeals.

Monday afternoon was devoted to breakout sessions with two hours of attorney ethics presented by the perennial favorite, Barbara Seymour from the Office of Disciplinary Counsel, claims adjuster ethics from Anne Noonan and Michael Burkett with Willson, Jones, Carter and Baxley, a introductory level seminar from Greg Line, Director of Claims at the SC Workers' Compensation Commission, and a presentation on the SafetyFirst program implemented at Spartanburg Regional Healthcare System from Mike Arntz.

Tuesday began with *Breakfast With the Commissioners*, which gave everyone a

chance to meet with and ask questions of the Commissioners in an informal setting, followed by a question and answer session. Dan McGarvey shared his insights on the impact of younger generations of workers on the workforce in the first formal presentation, and Lynn Szymoniak discussed fraud in the workers' compensation system. Dr. James Holmes discussed burn injuries and their treatment.

Wednesday's program began with coverage of the 6th Edition of the *AMA Guides to the Evaluation of Permanent Impairment* by Dr. Christopher Brigham. The medical theme continued with a presentation on neuropsychological assessment practices from Dr. David Fisher. Nathaneal Massey, a Kids' Chance scholarship recipient, then addressed the audience and told of overcoming adversity in his life. Wednesday also featured an attendee favorite, *Case Makers and Case Breakers*, where the commissioners discussed questions about the decision making process in a workers' compensation case.

The conference was not all work and no play. There was sporting competition on the Arthur Hills golf links in a Tuesday afternoon tournament and later that evening, The Fantastic Shakers, had everyone moving on the dance floor and a few conferees performing on stage.

Program evaluations indicated that the content and execution of the conference was very well received. 

NCCI Files for a 0.3% Cut in Loss Costs

In a rare bit of good news for South Carolina's employers, the National Council on Compensation Insurance said in November it had filed for a 0.3percent cut in workers' compensation loss costs effective July 1, 2009.

The proposed cut in loss costs, which is based on experience in 2005 and 2006, would be the first in South Carolina since 2001. Spokesmen for the South Carolina Chamber of Commerce and the South Carolina Small Business Chamber of Commerce indicated they expect more cuts in subsequent years as the state's workers' compensation system begins to benefit from legislative reforms passed in 2007.

Along with the proposed decrease in loss costs, another indication of the favorable climate is continued declines in market share of the assigned-risk pool. The residual market accounted for 14.6% of the total market in 2004, 12.1% in 2005, and 9.7% in 2006. NCCI calculates the assigned-risk pool now accounts for 7.7% of the total market.

The rate agency said a major reason it was able to file for a rate decrease are savings from the hospital payment system the South Carolina Workers' Compensation Commission implemented in October 2006.

NCCI estimates the payment system is saving insurance carriers about \$53 million per year.

Gary Thibault, executive director of the commission, said his agency puts the total savings to South Carolina employers at approximately \$98 million per year. NCCI's estimate is lower, he said, because it does not include savings to companies selfinsured for workers' compensation. NCCI collects data only from insurance carriers.

The proposed decrease in loss costs is in sharp contrast to NCCI's recent filings. In early 2007, NCCI filed for a 23.7% increase to be effective in December 2007 but settled for a 9.8% increase. In December 2006, an administrative law judge approved an 18.4% increase. NCCI had asked for a 32.9% increase. Although sharply reduced from the original request, the December 2006 increase was the third consecutive double-digit increase for South Carolina, as the insurance department had approved increases of 11.4% in 2004 and 17.5% in 2003.

Workers' compensation rates have been falling across the country, thanks to declining injuries among virtually all industries and all age groups. South Carolina employers have benefited from the trend, but not to the same extent as employers in other states.

In 2000, South Carolina was ranked 49 on Oregon's widely reported annual Workers' Compensation Premium Rate Rankings (48 states had higher premium rates than South Carolina). By 2006, South Carolina had slipped to 25th on the Oregon premium rate rankings, a deterioration which drew the ire of employers, insurers, self-insurers, and various groups which pushed for reform in the 2007 legislative session.

The slide continues. According to the 2008 Oregon ranking, released in October 2008, only 12 states have higher workers' compensation rates than South Carolina. The Palmetto State is ranked 13th on the report, which ranks all 50 states plus the District of Columbia for rates that were in effect in January 2008. Premium rates were the highest in Alaska, which was ranked number one.

2009 Maximum Weekly Compensation Rate Announced

The South Carolina Employment Security Commission has certified that the average weekly wage in South Carolina for the period July 1, 2007 through June 30, 2008 was \$681.36. Accordingly, for accidents that occur on or after January 1, 2009, the **maximum weekly compensation rate**, which according to Section 42-9-10 is to be "no more than the average weekly wage in this State for the preceding fiscal year," shall be **\$681.36**.

This raises the maximum weekly compensation rate by \$20.07, 3% greater than the 2008 rate of \$661.29. An individual's compensation rate equals 66²/₃% of an individual's average weekly wage, not to exceed the average weekly wage in South Carolina as determined by the South Carolina Employment Security Commission. In terms of total disability for 500 weeks, the maximum compensation award for 2009 will be \$340,680. Generally, an individual must have earned \$53,120 annually (\$1021.53 weekly) or more during the four quarters immediately preceding the quarter in which an accident occurs in order to be paid at the maximum compensation rate.
