Attorney Fee Petitions and Orders are submitted to the **Claims Department**
Forms 15,16,17,18, 19, 20, 24 go to the **Claims Department**
Commuted Value Requests are submitted to the **Claims Department**

Forms 50/51 go to the **Judicial Department**
Forms 52.53 go to the **Judicial Department**
Forms 54,55 go to the **Judicial Department**
Form 21 go to the **Judicial Department**

Litigation issues prior to hearing notice go to the **Judicial Department**

Hearing Notice Received. All issues to **Jurisdictional Commissioner**
Form 58's (Pre-hearing Briefs) go to the **Jurisdictional Commissioner**
Scheduling Issues go to the **Jurisdictional Commissioner**
Motions on scheduled hearings go to the **Jurisdictional Commissioner**
Proposed Decisions and Orders go to the **Jurisdictional Commissioner**

The SCWCC file remains with the Jurisdictional Commissioner until an order is served. Once the Decision and Order is served, the SCWCC file is sent to the Records Center.

INTO THE WOODS WITH THE GUYS AND TOTO. . .

Form 30's go to the **Judicial Department**

Appellate Briefs go to the **Judicial Department**

Respondent Briefs go to the **Judicial Department**

Scheduling Issues go to the **Judicial Department**

The file remains in the Judicial Department until oral argument has been made, and then the file goes to the Legal Department for service of the Appellate Decision and Order.

Appeals to Higher Courts Please notice the **Judicial Department**

Orders from a High Court Please notify the **Judicial Department**

Motions/Pleadings while in Higher Court go to the **Judicial Department**
